#### **DOCUMENT CERTIFICATION**

#### Procedure for customers who are unable to attend the Consulate in person:

For a private document (NOT related to Real Estate or Inheritance matters) to be accepted/recognised by the Serbian authorities, (power of attorney, statement, certificate, etc.) it has to be signed in front of and witnessed by a Justice of the Peace (JP) from the approved list of JPs below. The document is then sent to the Consulate General in Sydney for certification and returned to the customer.

## Document certification by a NOTARY PUBLIC (NP)

Power of Attorney documents involving Real Estate and Inheritance matters can be only certified by the Consulate General of Serbia if signed in person at the Consulate. These ddocuments can also be notarised by a Notary Public (NP) and in order to be recognised by Serbian authorities, legalised with the "Apostille" certificate, which is issued by: In Australia - Australian Passports Office Legalisation Services. Appointment is required, by phoning 1300 935 260. In New Zealand - please contact the NZ government on 0800 872 675 or visit www.govt.nz/authentications

(Notarised documents with Apostille do not need to be sent to the Consulate General in Sydney for certification)
