

List of JUSTICE OF THE PEACE and NOTARIES
WHO HAVE THEIR SIGNATURE REGISTERED AT
THE CONSULATE GENERAL OF THE REPUBLIC OF SERBIA - SYDNEY

Procedure for customers who are unable to attend the Consulate in person:

For a private document to be accepted/recognised by the Serbian authorities, (power of attorney, statement, certificate, etc.) it has to be signed in front of and witnessed by a **Justice of the Peace (JP)** from the approved list of JPs below. The document is then sent to the Consulate General in Sydney for certification and returned to the customer.

Payment of fees:

Document certification fee for one signatory is AUD \$73.00, payable to "The Consulate General of the Republic of Serbia" by bank cheque or money order. Additional \$7.00 is charged for postage in Australia, and \$15.00 international.

Document certification by a NOTARY PUBLIC (NP)

Documents notarised by a Notary Public (NP) are accepted by all authorities and institutions of the R. Serbia. Notarised documents then need to be authenticated with the "Apostille" seal from the relevant government authorities.

In Australia - please contact the Australian Passports Office. Appointment is required, by phoning **1300 935 260**.

In New Zealand - please contact the NZ government on **0800 872 675** or visit www.govt.nz/authentications

(Notarised documents with Apostille do not need to be sent to the Consulate General in Sydney for certification)

NOTE:

Fees for consular services provided to nationals of third countries that have an agreement, memorandum or similar with the R. Serbia (ie. Montenegro, B&H), are increased by 100% according to section B-Consular Fees as per ZORAT, except where the agreement specifies otherwise.
